**ADMINISTRATIVE ORDER REGARDING BUSINESS COURT**

**WHEREAS**, the Eighth Judicial District Court Rule 1.33 (b) provides that the Chief Judge must assign Judges of the District to the Business Court Division.

**WHEREAS**, the Eighth Judicial District Court Rule 1.61 provides for the assignment of Business Matters.

**WHEREAS**, the Chief Judge and the Executive Committee of the Eighth Judicial District Court has previously selected Judges Nancy L. Allf, Kathleen Delaney, Mark Denton, Elizabeth Gonzalez, and Susan Scann as the District Judges to hear Business Court matters pursuant to EDCR 1.33 and EDCR 1.61.

**WHEREAS**, it has become necessary to reassign a portion of Judge Susan Scann's Business Court matters and Judge Nancy L. Allf is willing to accept that portion of the existing case load.

Therefore,

**IT IS HEREBY ORDERED** that Administrative Order 2013- 02 is hereby amended.


**IT IS FURTHER ORDERED** that Judge Nancy L. Allf, Department XXVII, Judge Kathleen Delaney, Department XXV, Judge Mark Denton, Department XIII, Judge Elizabeth Gonzalez, Department XI, and Judge Susan Scann, Department XXIX, shall be the District Judges assigned Business Court matters for the Eighth Judicial District Court.


1           **IT IS FURTHER ORDERED** that, the cases on the attached Exhibit "A" will be  
2 reassigned to from Judge Susan Scann, Department XXIX to Judge Nancy L. Alf, Department  
3 XXVII.

5           **IT IS FURTHER ORDERED** that the new business court filings effective September  
6 21<sup>st</sup>, 2015 or after shall be assigned randomly, 1/4 to Department XI, 1/4 to Department XIII,  
7 1/8 to Department XXV, 1/4 to Department XXVII and 1/8 to Department XXIX to hear the  
8 Business Court docket. If one of the Business Court Judges named above is preemptorily  
9 challenged or otherwise recuses, the case shall be assigned to one of the other Business Court  
10 Judges. In those instances where all of the Business Court Judges have been preemptorily  
11 challenged or otherwise recuses, then the case shall be assigned to the Judge(s) assigned to  
12 preside over Business Court cases on a Conflict Basis. In those instances where all such Judges  
13 have been preemptorily challenged or otherwise recuses, then the case shall be assigned to the  
14 Chief Judge of the District Court.

17           **IT IS FURTHER ORDERED** that this Administrative Order shall be in effect on  
18 September 21, 2015, and shall continue until modified or rescinded by a subsequent  
19 Administrative Order.
