7 **WHEREAS** pursuant to Administrative Orders 10-03, 10-12 and 12-06, the
8 assignment of discovery matters for certain departments was made between Commissioner
9 Bonnie Bulla and Commissioner Chris Beecroft;

10 **IT IS HEREBY ORDERED** that, pursuant to EDCR 1.30, Administrative Orders
11 10-03, 10-12 and 12-06 remain in effect but certain departmental assignments shall be
12 modified as identified herein.

13 **IT IS FURTHER ORDERED** that Commissioner Bonnie Bulla shall continue to
14 perform all of the functions outlined in EDCR 2.55(b).

15 **IT IS FURTHER ORDERED** that Commissioner Bonnie Bulla shall be assigned to
16 hear discovery matters originating from the following District Court Departments: 1, 2, 3, 5,
17 6, 7, 9, 10, 11, 13, 15, 16, 18, 20, 22, 23, 25, 26, 27, 28, 29, 30, 31, and 32 filed or submitted
18 on or after January 5, 2015.

19 **IT IS FURTHER ORDERED** that Commissioner Chris Beecroft shall be assigned
20 to hear discovery matters originating from the following District Court Departments: 4, 8,
21 12, 14, 17, 19, 21, and 24 and filed or submitted on or after January 5, 2015.


22 **IT IS FURTHER ORDERED** that if one of the Commissioners hearing Discovery
23 matters is disqualified or recuses from consideration of a particular case that the discovery
24 matters in that case will be heard by the other Commissioner hearing discovery matters.

25 **IT IS FURTHER ORDERED** that this Administrative Order will not affect: (1)
26 cases assigned to a business court docket; (2) cases in which a District Judge has designated
27 the matter as complex pursuant to NRCP 16.1(f); or (3) cases in which a District Court Judge
28 has otherwise assumed the responsibility for handling discovery matters.
