Administrative Order: 16-04


WHEREAS Rule 1.30 of the Rules of Practice for the Eighth Judicial District Court of the State of Nevada (“EDCR”) charges the Chief Judge of the Eighth Judicial District Court with various responsibilities, such as supervising the administrative business of the court, ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the court’s duties are timely and orderly performed, and otherwise facilitating the business of the court.

IT IS HEREBY ORDERED, pursuant to EDCR 1.30(b)(14) and EDCR 1.30(b)(15), that 100 open civil cases aged 36 months or less shall be randomly selected from Department 15 and reassigned to Department 29.

IT IS FURTHER ORDERED that court administration shall publish on the Court’s website a list of those cases affected by the reassignment.

IT IS FURTHER ORDERED that the aforementioned reassignment shall take effect on June 1, 2016.
