Administrative Order: 24-03

WHEREAS, the Eighth Judicial District Court, as part of the state constitutional judicial system, "has the inherent power to protect itself and to administer its affairs." *City of N. Las Vegas ex rel. Arndt v. Daines*, 92 Nev. 292, 294, 550 P.2d 399, 400 (1976); and,

WHEREAS, The Chief Judge is responsible for supervising the administrative business of the Eighth Judicial District Court, ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the court's duties are timely and orderly performed and otherwise facilitate the business of the District Court.
