8 **WHEREAS**, the Eighth Judicial District Court, as part of the state constitutional
9 judicial system, “has the inherent power to protect itself and to administer its affairs.”
10 *City of N. Las Vegas ex rel. Arndt v. Daines*, 92 Nev. 292, 294, 550 P.2d 399, 400
11 (1976); and,

12 **WHEREAS**, The Chief Judge is responsible for supervising the administrative
13 business of the Eighth Judicial District Court, ensuring the quality and continuity of its
14 services, supervising its calendar, reassigning cases as convenience or necessity
15 requires, assuring the court’s duties are timely and orderly performed and otherwise
16 facilitate the business of the District Court. NRS 3.025; *see also* EDCR 1.30(b). This
17 Court now modifies the following assignments to further foster consistency, efficiency,
18 and fairness.

19 **IT IS THEREFORE ORDERED**, pursuant to EDCR 1.30(b), effective August
20 12, 2024, one-hundred cases currently assigned to Department 11 shall be reassigned to
21 Department 21 and forty cases currently assigned to Department 4 shall be reassigned to
22 Department 21.

23 **IT IS FURTHER ORDERED**, the reassigned cases shall be randomly selected
24 from only new cases filed during the period from March 1, 2024 to the present.


25 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), the EJDC
