Administrative Order: **24-08**

9 **WHEREAS**, the Eighth Judicial District Court, as part of the state constitutional
10 judicial system, “has the inherent power to protect itself and to administer its affairs.” *City of N.*
11 *Las Vegas ex rel. Arndt v. Daines*, 92 Nev. 292, 294, 550 P.2d 399, 400 (1976); and,

12 **WHEREAS**, the Chief Judge is responsible for supervising the administrative business
13 of the Eighth Judicial District Court, ensuring the quality and continuity of its services,
14 supervising its calendar, reassigning cases as convenience or necessity requires, assuring the
15 court’s duties are timely and orderly performed and otherwise facilitate the business of the
16 District Court. NRS 3.025; *see also* EDCR 1.30(b).

17 **WHEREAS**, the general election is Tuesday, November 5, 2024 (“Election Day”). By
18 this order, the court intends to prepare for the possibility that actions pertaining to the election
19 process may be filed during or after regular business hours and further intends to implement a
20 fair and expeditious process by which election-related actions can be heard and adjudicated
21 through the end of Election Day.

22 **WHEREAS**, the court pursuant to Administrative Order 24-07 previously designated
23 the district court judges assigned to Departments 5, 6 and 9 to serve as Election Day judges. In
24 accordance with NRS 1.070(1)(b), NRS 3.025(2)(c), EDCR 1.30(b)(9), and more importantly
25 to ensure the safety and security of the Judges, court staff, marshals, and the Regional Justice
26 Center, the court deems it in the best interests of justice that for any election-related matter
27 filed on Election Day that requires a hearing to take place on Election Day after 5:00 p.m., for
28 that hearing to be held virtually before one of the designated Election Day judges.

1 **IT IS THEREFORE ORDERED**, pursuant to EDCR 1.30(b)(18), if an election-
2 related matter is filed on Election Day and requires a hearing to take place on Election Day
3 after 5:00 p.m., then that hearing shall be held virtually via Zoom, at the below-listed Zoom
4 links. Parties and their Counsel of Record shall appear via Zoom before their assigned Election
5 Day judge.

7 or the hearings will also be provided by live-stream, and will be accessible through the
8 following link: <http://www.clarkcountycourts.us> To view and attend any election-related
