Administrative Order: **25-03**

WHEREAS, the Chief Judge is responsible for supervising the administrative business of the Eighth Judicial District Court, ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the court's duties are timely and orderly performed, and otherwise facilitating the business of the Court; NRS 3.025; EDCR 1.30(b).

IT IS HEREBY ORDERED, pursuant to EDCR 1.30(b), that all criminal cases currently assigned to Department 22 (JC Track 12) shall be reassigned to Department 15.

IT IS HEREBY ORDERED, pursuant to EDCR 1.30(b), that all criminal cases currently assigned to Department 15 (Outlying Rural Track) shall be reassigned to Department 14.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30(b), that 500 of the most recently filed civil cases currently assigned to Department 14 shall be randomly reassigned to all remaining departments in the General Jurisdiction Division, except Department 12 and Department 32.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30(b), that the aforementioned reassignments shall take effect on March 31, 2025.
